AGREEMENT BETWEEN

CULTURE INFORMATION PASTORALIST DEVELOPMENT AND

PASTORALIST FOUNDATION FOR LIFE

INTRODUCTION

This agreement between Culture Information Pastoralist Development herein referred to as CIPAD and Pastoralist Foundation for Life herein referred to as PFL, establishes the broad **Mutual** understanding regarding their relationship in implementing the health care service required for orphans and vulnerable children registered under OVC care and support in the project area in Sololo district.

We recognize the **Autonomy** of each organization and enter this agreement in a spirit of mutual **trust and respect**.

This agreement is therefore a statement of mutual intent to which the two (2) organizations are bound.

The objective of the agreement is to provide holistic health care service to 326 registered OVC at Obbitu children's village and at their extended families or guardians.

NOW THEREFORE, in consideration of the above the parties hereto do hereby agree as follows:

OBLIGATION OF CIPAD

- CIPAD shall provide funds for PFL to provide health care services to OVC in HBC and Obbitu children village.
- CIPAD shall pay ______ on monthly basis to PFL to undertake holistic health approach, nutritional monitoring, treatment, follow-up, referral and sanitation of households of OVC under CIPAD CARE AND SUPPORT.

OBLIGATION OF THE PFL:

- To conduct mobile out reaches for OVC living with their guardians on monthly basis and under take the following at household level
 - Monitor nutritional, growth and development of HBC children
 - Provide quality treatment to all sick children and make follow up
 - Make appropriate referral for further case management to Sololo hospital
 - Conduct monthly health assessment of all children registered under OVC at their respective centers
 - Fill in the health record book of each child for medical record, follow-up and monitoring
 - Make a detailed narrative report of health care activities on monthly basis to CIPAD
 - Receive sick children from families and guardians for case management or referral at a PFL registered Address.(HEMS MEDICAL CLINIC SOLOLO)
- Visit to Obbitu children and monitor their health, treatment of the sick and appropriate referral for case management on weekly basis or when called upon
- Provide first Aid drugs to Obbitu children village to manage minor ailment by the staffs

- Respond to emergency call to attend to sick child at HBC and Obbitu children village
- Acknowledge and provide receipt voucher for the cash received from CIPAD
- Conduct mobilization of out reaches prior to visitation

DISPUTE RESOLUTION AND QUALITY SERVICE DELIVERY

- CIPAD demands that PFL to provide skilled manpower, commitment and adequate time for the health care service of the OVC.
- There shall be quarterly review meeting to monitor progress and quality of service
- In case of any dissatisfaction of service both parties shall launch complain and a meeting organized to solve the dispute amicably.
- If the dissatisfaction persists then both parties may willingly terminate the agreement in writing.
